## REQUEST FOR QUALIFICATION PROJECT: BUSINESS SURVEY COLLECTORS

Child Care Associates (CCA) is seeking a qualified Business Survey Collector to work in collaboration with the Research Manager to gather survey responses and data collection for a research project focused on childcare policy. The ideal candidate will have strong experience in the fundamentals of small business management to collect accurate financial data needed for a research study. This is an exciting opportunity for seasoned small business owners, child care owners and managers who are skilled communicators to ensure the integrity of data collection.

## A. BACKGROUND

CCA is committed to advancing research and policy development in the field of childcare, with a focus on improving financial models and understanding the impact of policy on childcare systems in Texas. This research initiative purpose is to explore financial contracts in childcare, review state history and policy, and analyze both qualitative and quantitative data related to the sector.

- Business Survey Collectors will meet regularly with project team members to assess progress and address any challenges
- Business Survey Collectors will meet regularly with Program Manager to review progress individually
- Evaluation of project outcomes against predetermined objectives
- Solicitation of feedback from stakeholders to inform continuous improvement

- Proficiency in collecting and managing data documentation (surveys, interviews)

- Familiarity with educational and/or early childcare education systems, particularly in Texas
- Must demonstrate a high level of initiative and the ability to work well independently.

- Bi-lingual Spanish preferred.
- Experience with technology tools for data collection
- Comfortable utilizing virtual technology essential for working remotely (Zoom, WebEx, and Microsoft Teams).
- Ability to effectively manage multiple projects simultaneously

## **H. INTERVIEWS**

Top scoring Proposers may be asked to participate in a virtual interview. The Proposer will be provided a maximum of 30 minutes to cover qualifications, experiences, and approach. CCA will provide additional information regarding the interview process to the top scoring Proposers.
